Integrated D-SNP SEP - PY2025

Overview

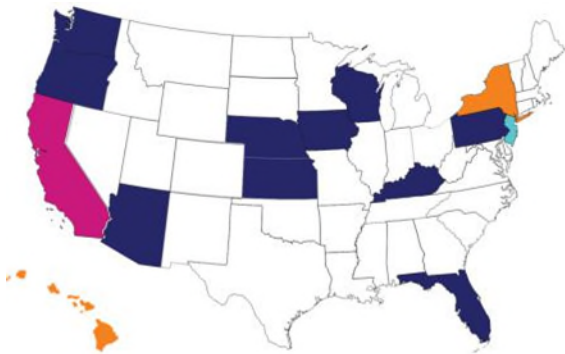
Full-benefit dual eligible beneficiaries have a Special Election Period (SEP) allowing them to make a one-time-per-month election into a Fully Integrated Dual Eligible Special Needs Plan (FIDE-SNP), a Highly Integrated Dual Eligible Special Needs Plan (HIDE-SNP), or an Applicable Integrated Plan (AIP). This SEP is only available to facilitate aligned enrollment.

D-SNP election period changes apply to 1/1/2025 effective dates and beyond. The new Integrated D-SNP SEP is available for use in December 2024 for a 1/1/2025 effective date, but does not apply during the Annual Election Period (AEP). AEP, MA-OEP, and other SEPs continue to be available regardless of plan type.

Important!

Agents/brokers are strongly encouraged to verify the beneficiary's level of Medicaid eligibility. This can be done by using support tools like the Special Populations (SPOP) line at 866-211-0544 as well as self-service tools available in our enrollment platforms.
