

TERMS AND CONDITIONS 2023

For bookings where Active Scandinavia is the operator the terms and conditions of Active Scandinavia apply. Additionally to these terms and conditions following agreements are made:

1) Commission

<i>All tours, except based in one hotel tours</i>	<i>Commission</i>
Base price per person in a double room with breakfast	20%
Single room surcharge	20%
Extra night per person in a double room with breakfast	10%
Extra night per person in a single room with breakfast	10%

<i>Based in one hotel tours</i>	<i>Commission</i>
Base price per person in a double room with breakfast	15%
Single room surcharge	15%
Extra night per person in a double room with breakfast	10%
Extra night per person in a single room with breakfast	10%

No commission on all other services (e.g. rental bikes).

2) Cancellations / Rebookings / Changes of reservations

A booking is definite from the moment when Active Scandinavia confirms it per email. A cancellation needs to be in writing. In case of a cancellation following fees apply:

until 28 days before arrival	20%
from 27-14 days before arrival	30%
from 13-8 days before arrival	50%
from 7-4 days before arrival	70%
from day 3 or due to "no show"	100%

Changes to the booking in terms of number or types of rooms, hotel category or similar is possible up to 14 days prior to the start of travel. For each change, we charge SEK 500 per person.

3) Child reduction

If there is nothing else mentioned in the tour offers, following child reductions apply:

0-5.9 years	100%
6-11.9 years	50%
12-14.9 years	25%
15-17.9 years	10%

The child reduction is calculated from the base price and only valid if children are staying overnight in the room of two full-paying adults (three-bed or four-bed). No child reduction on bikes. Eventual costs for a crib, food etc. are payable on spot directly to the hotel.

4) Booking

Bookings and confirmations are upon request.

5) Usage of photos

Images supplied by Active Scandinavia may only be used to advertise trips that are booked with Active Scandinavia. In the event of misuse, Active Scandinavia reserves the right to assert claims for damages.

6) Payment / Travel documents

Together with the booking confirmation you will receive an invoice for every booking. Payment is due the latest 14 days before the arrival date of customers. The payment must be free of charges for Active Scandinavia. Payments should be in SEK, mentioning the invoice number and customer's name.
