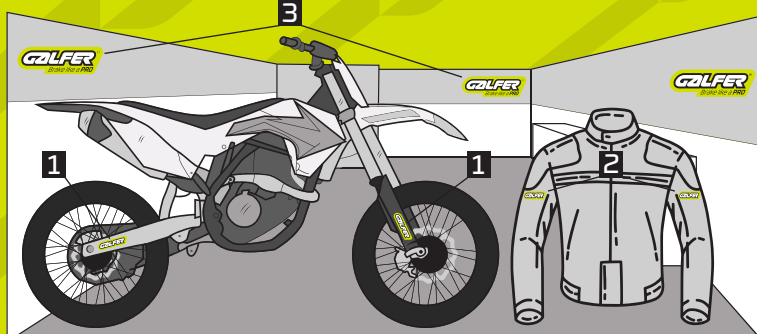

# SPONSORING FORM 2025



Dear partner, find detailed the terms of sponsorship for the race season 2025:

1.- The period to review and approve the season sponsorship request will be from the 1st of October 2024 until the 31st of March 2025. The partnership will last until the 31st of December 2025, or any other date specified.

2.- It is mandatory to return this SPONSORING FORM completed and signed to accept the sponsorship request and get the brake products delivered.

3.- Only one request of material will be considered for the 2025 full season. This material is property of GALFER, that can ask for its return at any moment of the season.

4.- In case of any problem with the brake products, the team must immediately contact the Galfer technical staff in order to verify the issue as soon as possible.

5.- Industrias GALFER commits to deliver the agreed braking material valued in \_\_\_\_\_ (RRP price) as a collaboration with the team/ rider during the 2025 race season within the deadlines that GALFER may consider appropriate.

6.- Industrias GALFER will contribute financially with the team/rider with \_\_\_\_\_.  
The payment(s) will be made in \_\_\_\_ times and effective 30 days after receiving the invoice(s), day 15th monthly.

7.- The vending of this material is absolutely prohibited being its destination only for sportive use.

8.- In consideration, the team will show the GALFER logo on motorcycles, box, clothes, vehicles, press releases, web page, social networks, posters, etc... according to the use new GALFER logo rules in races, official trainings, events and shows. Equally, the team will report GALFER about his results achieved through press releases and provide photographs / videos of the competitions at [dortiz@galfer.es](mailto:dortiz@galfer.es) and [lvancells@galfer.es](mailto:lvancells@galfer.es). GALFER will have the right to use all materials received for advertising and/or promotional purposes.

9.- If the team/riders don't use the Galfer brake products at races, official trainings, events or shows in which takes part, it will be withdrawn all the brakes product delivered, except if Galfer hasn't delivered the products on time. Also, this contract will be canceled immediately and Galfer will have no obligation to make any further payments from the time the rider/team has used other brake products.

10.- The team will publish 6 different posts and several stories dedicated to GALFER in their social networks during the season (Instagram, Facebook, Tik Tok, Twitter, LinkedIn), always mentioning @galfermoto account and the hastags #galfer, #galferbrakes, #ad. Also, it's agreed a Product review and publish in the social channels as well. GALFER will have the right to reuse for advertising and/or promotional purposes, as well as to publish in its social networks, any material published by the rider, his team or any third party as long as such material contains a reference to the GALFER brake products object of this sponsorship or to the brand GALFER itself.

11.- Both parties commit not to publish negative statements that damage or violate public order, moral, decent or legislative elsewhere.

12.- The shipping costs of the material are borne by Industrias GALFER. The material can also be collected at GALFER facilities in Granollers, Barcelona (Spain).

13.- This agreement will not be valid in the case of the team/rider withdraws from the competitions due to whatsoever reason or if the championships organizers cancel the events. Given that case, the team/rider must return all the brake products and money to Galfer.

14.- The Team will be available for tests with technical presence from Galfer team during the season, at agreed dates and locations.

15.- In compliance with the Organic Law 3/2018, of December 5, on Personal Data Protection and guarantee of digital rights, we inform you that the personal data provided, and the ones related with the partnership established with INDUSTRIAS GALFER will form part of our data base, in order to manage the sponsorship of riders and teams. The sponsorship agreement involves that the sponsored consents the public disclosure of the sponsorship agreement reached.
